BANK ACT OF CALIFORNIA

AN ACT TO DEFINE AND REGULATE THE BUSINESS OF BANKING

The People of the State of California, Represented in Senate and Assembly Do Enact as Follows:



ARTICLE I. GENERAL PROVISIONS.

Section 1. This act shall be known as the "bank act," Act named "bank and shall be applicable to all corporations specified in the next section and to such other persons, associations, copartnerships or corporations who shall, by violating any of its provisions, become subject to the penalties provided therein.

Section 2. The word "bank" as used in this act shall "Bank" defined. be construed to mean any incorporated banking institution which shall have been incorporated to conduct the business of receiving money on deposit, or transacting a trust business as herein defined. The soliciting, receiving what deemed comor accepting of money or its equivalent on deposit as a morcial or savings regular business shall be deemed to be doing a commercial or savings bank business whether such deposit is made subject to check or is evidenced by a certificate of deposit, a pass book, a note, a receipt or other writing; provided, that nothing herein shall apply to or include money or its equivalent left in escrow or left with an agent, pending investment in real estate or securities for or on account of his principal. It shall be unlawful for Transacting banking any corporation, partnership, firm or individual to engage than by means of in or transact a banking business within this state except unlawful.
