PREFACE.

A GENERAL SYNOD of the EPISCOPAL CHURCH IN SCOTLAND was held in Edinburgh on Tuesday, October the 10th, 1876, and the three following days, and thereafter adjourned to Tuesday, November the 14th, and continued by adjournment from day to day till Thursday, November the 16th, to consider certain alterations of and additions to the Code of Canons of 1863; and the result of their deliberations, as formally approved by both Chambers, is embodied in the present Code, bearing date November the 16th, 1876; and the said Synod do hereby adopt, enact, and sanction the said Code, and the Appendix thereto annexed, as now revised, amended, and enlarged, and declare the same to be in future the Canons and Laws of the EPISCOPAL CHURCH IN SCOTLAND.
