ORIGIN OF POOR-RATES.

THE first act of parliament for the ge- No law for neral relief of the poor, was passed in the the poorbefourteenth year of the reign of Queen Eli- 14th Elia. zabeth ; before that time their wants were chiefly supplied by charitable institutions, and the donations of the benevolent. Monasteries and hospitals were richly endowed for supporting the clergy and providing for the poor; and the property of persons

dying intestate was vested in such institutions for the same charitable purposes.

First occasion for the general At the commencement of the Reformation, in the reign of Henry the Eighth, the monastic clergy were possessed of about one-fifth of the revenues of the kingdom, which that monarch seized and distributed amongst his courtiers and flatterers, as a reward for their servility. The poor soon felt the inconvenience of being deprived of their support, and the country, in consequence, became so much infested with beggars and indigent persons, that it was found necessary to provide for them by a general tax.

The poor supported During the recess, betwixt the suppression of the monasteries, and the commencement of the operation of the poor laws, paupers were restrained from begging out of their own district or parish, and were provided for by voluntary contributions collected in the churches. The clergy were directed, by government, to exhort their parishioners to be liberal and bountiful. Once a-year, at the conclusion of divine
