## REPORT OF THE COUNCIL

OF

# The Pipe Roll Society.

*Read at the Committee Meeting on the 22nd November, 1898.*

---

THE present Volume, Vol. XXIII., is a continuation of Vol. XX., which was issued in 1896, and contained a collection of the Feet of Fines of the 7th and 8th years of Richard I.

In this volume are printed one Fine of the 8th year of Richard I., which should have been included in Vol. XX., and all those in the Public Record Office of the 9th year of the same King, arranged in chronological order, as in Vols. XVII. and XX.

As stated in a circular which was sent to all the members of the Society about a year ago, the number of members has considerably diminished of late years by death, and there are very few new members to make up for this loss.

The annual income of the Society does not, therefore, enable the Committee to give as much as it considers it ought to give, in return for the annual subscription, nor is it sufficient to justify the Committee in having any more Pipe Rolls transcribed.

The Committee, however, possesses transcripts of the remaining Feet of Fines of the reign of Richard I., which are sufficient to make another volume; and it proposes, if subscriptions are forthcoming to meet the cost, to print these Feet of Fines as the concluding volume of the Series.

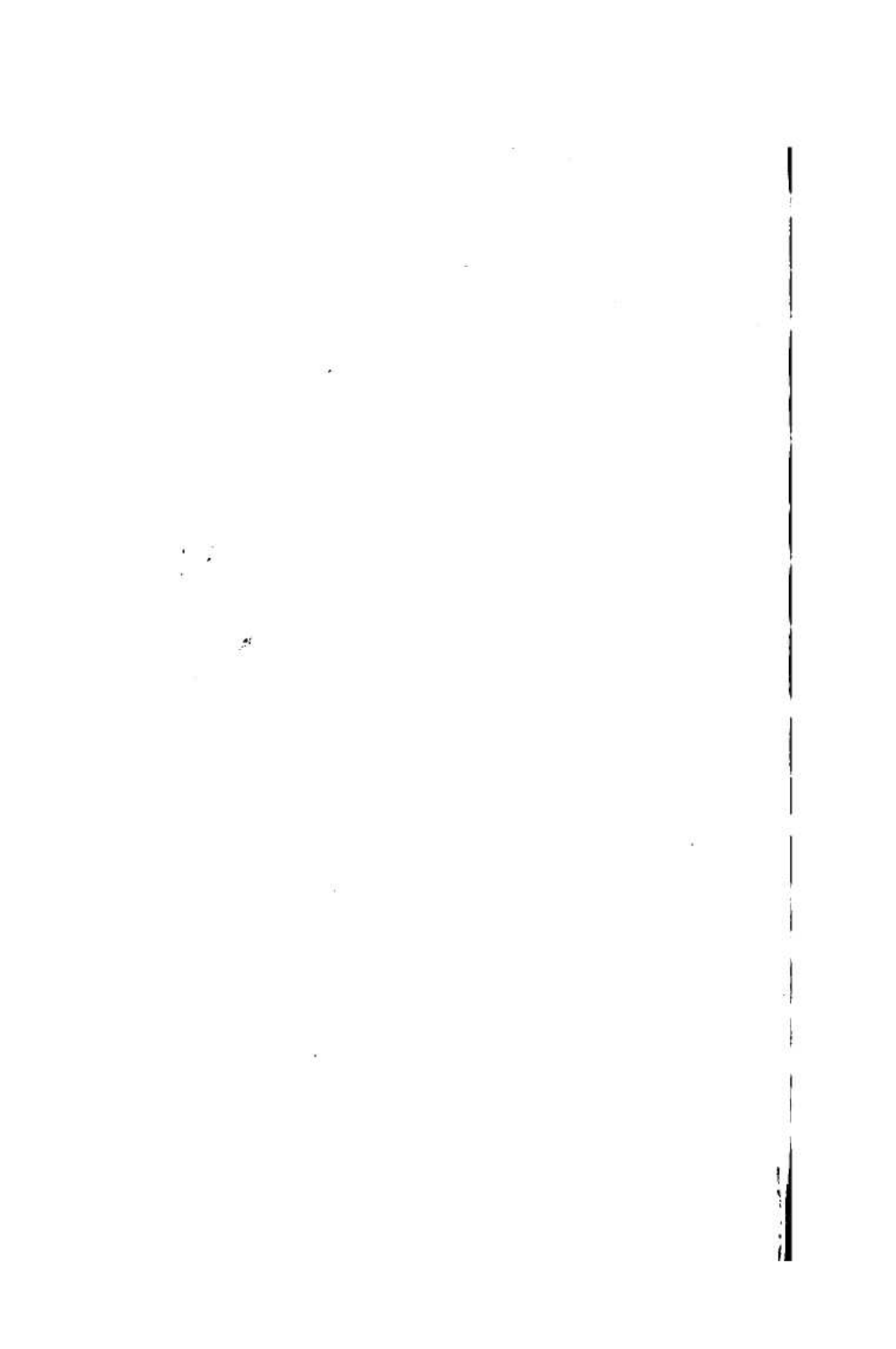
