

Rules.

I.

The objects of the Society are the study and, as far as possible, the recording of antiquarism and historical matters, especially in regard to the Borough of Hampstead, and also, should necessity arise, the protection of any historic landmark from needless violation.

The Officers of the Society shall consist of a President, Vice-Presidents, and an Honorary Secretary (who shall also act as Treasurer), all of whom shall be elected at the Annual Meeting.

TIT

The business of the Society shall be managed by a Council, consisting of the President, Hon. Secretary, and ten members, who shall be elected at the Annual Meeting. Any vacancy amongst the Officers or on the Council shall be filled up at the second Ordinary Meeting of the Society after the occurrence of such vacancy, due notice thereof having been given to members. No business shall be brought before the Ordinary Meetings of the Society unless it has been previously considered by the Council and due notice thereof given to Members. Matters of special urgency may be discussed at any Ordinary Meeting of the Society, provided the consent of two-thirds of the Members present be obtained.

IV.

Members shall be elected by the Council. The Annual Minimum Subscription shall be 5s., payable in January of each year. Each Member shall have the privilege of introducing two friends to all Ordinary Meetings of the Society.

V.

The Annual Meeting shall be held at such date as may be fixed by the Council.

VI.

These Bules shall not be altered or rescinded, except at a General Meeting specially summoned for that purpose. A Special Meeting shall be called on a written requisition, signed by not less than six Members, being sent to the Honorary Secretary, not less than fourteen days previous to the date of the desired Meeting.
